MINUTES OF THE MEETING HELD ON WEDNESDAY, MAY 24TH, 2023 IN BURNLEY GOLF CLUB.

Following the recent election, the new councillors signed the declaration of acceptance of office form and agreed to follow the code of conduct devised by Burnley Borough Council. There were no changes to the Register of Interest forms.

1. Apologies for absence

2. Minutes of the last meeting

3. Matters arising from minutes

3.1 Bull and Butcher garden

The buttercross is now in situ and has been well received by residents and complimented by The Milestone Society. The grass at the parish garden is being cut by the care home, but maintenance of the garden will come under the parish council. Coun PG Osbaldeston is to meet with the care home owner to arrange for a one off make over of the garden following the completion of the construction work.

3.2 Fairways Drive ginnel

The bin has been replaced. Coun Drain is cutting the grass and was thanked for his efforts. The clerk to ask BBC for dog fouling posters to be put.

3.3 Project to upgrade pathways and green spaces off Moseley Road

The project is now finished and has been well received. There has been a small amount of vandalism, which is being monitored by local police.

3.7 Helm Close and Wilkie Avenue wildflowers

3.9 (i) Code of conduct

Councillors had attended the Code of Conduct meeting organised by BBC, those who missed, had been sent a new date, as this course is mandatory.

PSCO Clark had sent in police reports for the last few months. Coun Markarian raised issues of dogs off leads in Towneley Woods and was advised on the procedure to get signs setting out the byelaw for rules on controlling dogs in public spaces.
