MINUTES OF THE MEETING HELD ON WEDNESDAY, AUGUST 2ND, 2023 IN BURNLEY GOLF CLUB.

1. Apologies for absence

2. Minutes of the last meeting

These were accepted.

3. Matters arising from minutes

3.1 Bull and Butcher garden

The WWII plinth has been moved to the stone in the garden and the volunteer gardener has planted up the garden area and has agreed to maintain this and the trough by the escape road. The care home to continue cutting the grass.

3.2 Fairways Drive ginnel

The bin has been replaced. Coun Drain asked for authorisation to order a brown bin and buy shears to use cutting over vegetation. This was approved.

3.3 Project to upgrade pathways and green spaces off Moseley Road

There has been a problem with a blocked culvert, which is flooding the path. LCC to investigate. A member of the public had asked if any work was to be done at The Kilns as an extension to the project, the clerk to ask LCC.

3.4 Helm Close and Wilkie Avenue wildflowers

The wildflower project for Wilkie Avenue has started and will be completed in September. BBC will not cut or maintain the area of land which is privately owned. The residents in Helm Close have rejected the offer of a

wildflower meadow,

3.5 Tipping at Micklehurst Farm

Concern that limestone appears to be now being taken up to the farm in vehicles where the numberplates are missing or un readable. The clerk to ask BBC for an update. Coun Brindle to investigate.

3.6 Ginnel between Rossendale Road and Helm Close

LCC has completed some work on the ginnel.

3.7 Code of conduct

The two councillors who missed the course are awaiting instructions from BBC for a new course.

3.8 Road defect and overgrown vegetation in Glen View Road

These issues have been resolved.

3.9 Lengthsman
